CORONAVIRUS (COVID-19) ADVISORY NOTICE

Consistent with Executive Orders No. N-25-20 and No. N-29-20 from the Executive Department of the State of California and Contra Costa County March 16, 2020 Shelter in Place Order and the Updated Stay-at-Home Order with New Restrictions issued on April 29, 2020, effective May 4, 2020, extending the Shelter in Place Order through May 31, 2020, the Regular Meeting will not be physically open to the public and all Board Members will be teleconferencing into the meeting via Microsoft Teams. If a comment is received after the agenda item is heard but before the close of the meeting, the comment will still be included as a part of the record of the meeting but will not be read into the record.
